In 2009, the Canadian Environmental Accreditation Commission (CEAC) was established, in collaboration with the Association of Accrediting Agencies of Canada (AAAC), to serve as a neutral third-party to oversee the Accreditation program. The CEAC has approved the National Accreditation Standard (NAS) for Post-Secondary Environmental Programs.
